

**TOWN OF DICKINSON
NOTICE OF PUBLIC HEARING**

TAKE NOTICE that a public hearing will be held by the Town Board of the Town of Dickinson on July 11, 2016 commencing at 5:30 p.m. at the Polish Community Center, 347 Prospect Street, Binghamton, New York 13905 regarding the plan for dissolution of Garbage District No. 1 and Extensions Nos. 1 and 2 in the Town of Dickinson. A summary of the dissolution plan is as follows:

(1) The name of the District to be dissolved: Garbage District No. 1 and Extensions Nos. 1 and 2.

(2) The territorial boundaries of the District: Map on file at office of Town Clerk.

(3) The type and/or class of the District: Special improvement district, specifically collection and hauling of garbage and recyclable materials.

(4) A fiscal estimate of the cost of dissolution: \$1,000.00.

(5) Any plan for the transfer or elimination of public employees: Not applicable.

(6) The District's assets, including but not limited to real and personal property, and the fair value thereof in current money of the United States: The District has no assets.

(7) The District's liabilities and indebtedness, bonded and otherwise, and the fair value thereof in current money of the United States: The current year contract (January 1, 2016 – December 31, 2016) in the amount of \$123,770.00.

(8) Any agreements entered into with the Town in order to carry out the dissolution: Not applicable.

(9) The manner and means by which the residents of the District will continue to be furnished municipal services following the District's dissolution: Town residents will enter private agreements with local haulers, most likely Taylor Garbage and Bert Adams Disposal, at a cost equivalent to Town residents outside the District.

(10) Terms for the disposition of the District's assets and the disposition of its liabilities and indebtedness, including the levy and collection of the necessary taxes and assessments therefor: The funds in the District account, which were collected through property tax levy, will be expended to pay the existing contract, which runs through 2016. As of December 31, 2016, a liability of \$7,468.30 will exist for the final month's payment (December 2016) of the existing contract. This amount will be collected and paid through the 2017 tax levy.

(11) Findings as to whether any local laws, ordinances, rules or regulations of the entity shall remain in effect after the effective date of the dissolution or shall remain in effect for a period of time other than as provided by section seven hundred eighty-nine of this title: Not applicable.

(12) The effective date of the proposed dissolution: January 1, 2017.

The plan for the dissolution of Garbage District No. 1 and Extensions Nos. 1 and 2 can be viewed at the office of the Town Clerk, on the Town's website, www.townofdickinson.com, or at the Polish Community Center.

Any person shall be entitled to be heard upon said proposed Local Law, a copy of which is available for review at the Town Clerk's Office.
