

## Town of Dickinson Tax Collection Schedule for 2017

\*Credit/Debit card, ACH and e-check payments can be made on your tax bill from January 1<sup>st</sup> until March 31<sup>st</sup> 2017. Go to [www.taxlookup.net](http://www.taxlookup.net) and follow the directions. There is a convenience fee charged by the bank on credit/debit payments of 3% plus 50¢ and a \$4.95 fee for ACH/e-check. **On April 1<sup>st</sup> 2017 your unpaid taxes become delinquent and this form of payment can no longer be accepted.**

\*To confirm your tax is paid, go to [www.taxlookup.net](http://www.taxlookup.net) and search for *Payment History*; this website is updated through April 1<sup>st</sup> 2017. If you pay in person, the tax collector will stamp your bill paid.

\*Do not pay multiple towns/city with one check – separate check required for each town.

\*Do not staple, tape or paperclip your payment to the coupon.

**January: Each Monday, Wednesday and Friday and Tuesday January 31<sup>st</sup>  
9:00 am to 3:00 pm - Except Holidays including Monday, January 2<sup>nd</sup>  
(No penalty in January)**  
  
**February: Tuesday, February 28<sup>th</sup> 11:00 am to 3:00 pm  
(1% penalty in February)**  
  
**March: Friday, March 31st 11:00 am to 3:00 pm  
(2% penalty + \$1.<sup>00</sup> in March)**

- 5) An on-site box is available in the vestibule for drop off payments.

**Walk-in payments are accepted Monday through Friday from 8 am until 5 pm on the Second Floor of the Broome County Office Building, 60 Hawley Street, Binghamton, NY, except for holidays.**

### **DELINQUENT TAX INFORMATION:**

- 1) If you have delinquent taxes and wish to pay the full amount due call (607) 778-2161.
- 2) Delinquent taxes can be paid by entering an Installment Agreement, which requires a 25% down payment with 24 monthly payments at 1% interest per month. During the agreement all new taxes must be paid on time. For more information or to set up an agreement, call our AUTOMATED TAX LINE at (607) 778-6431. You will be asked to leave the necessary information and your call will be returned with details on the installment program.
- 3) **You MAY NOT pay delinquent taxes with Credit/Debit card, ACH or e-check.**
