SUPERVISOR'S REPORT

May 2024 Town Board Meeting Supervisor's Report

- 1. I reviewed the credit card charges and did not see any issues.
- 2. I received a copy of the Municipal Shelter Inspection report for the BC Dog Shelter, there continue to be unsatisfactory issues with walls and floors maintenance, multiple records incomplete for intake and disposition, multiple dogs not transferred in compliance with Article 7, which is adoption of various dogs, 1 dog was euthanized without documentation as to why, 1 dog redeemed to owner without proof of license, multiple dogs redeemed to owners with incorrect redemption fees charges.
- 3. We are seeing an increase of activity at our Sunrise terrace Park mostly by individuals living at the hotels across from the park. Stones from around our maintenance shed are being thrown about the park and basketball court, a great deal of litter from fast food establishments is left on benches and on the ground, loitering by homeless individuals are seen camping out in out ball field dugouts, damage to our fence around the pump station, kids digging holes around the park that could cause an accident, individuals who appear to be under the influence hanging around the park and along our streets, etc. I have notified the sheriff's department, and I wrote a letter to the hotel owner, and copied the Couty Executive and DSS Director illustrating our serious concerns about these activities. Residents are voicing their concerns and are afraid to bring their children to the park. I had a discussion with the

hotel owner, and he is planning to have some playground devices installed behind the hotel for his guests and he will also share my concerns with them. I also copied a Facebook message from a resident in Sunrise Terrace that had a very negative experience at the park with a confrontation with some youths from the hotel that was threatening. The resident had her very young child with her. This is totally unacceptable and must stop.

- 4. We finally received our 1st quarter funds for sales tax: \$275,986.34 and 1st quarter fees for inmates from other jurisdictions housed at the Broome County jail for \$17,120.09.
- 5. I was informed by our town judges that they hired someone for the position of court clerk. She started a few weeks ago and is doing a very good job. I was also informed that they are looking for a replacement for the court security officer who recently took a full-time position with Broome County Sheriff's office.
- 6. Darrell attended an AOT sponsored seminar on Finance.
- 7. Darrell found this event very informative in relation to his duties here in our town.
- 8. In regard to the NY Association of Towns, our new Executive Director, Chris Koetzle, former Supervisor of the Town of Glenville, started his position on May 1. There are many changes in staffing, all positive, and new members of the Executive Board being inducted into the Executive Board. I had a Zoom Officers meeting this morning to go over the changes and we will meet in person in Albany on the 21st.

PUBLIC COMMENTS

Fire Chief Delanoy from the Prospect Terrace Fire Company commented that he would like to request the help from the Town of Dickinson to get back the BOCES fire contract. He felt he was moving in a good direction when he met with the superintendent of the school. She allowed him to speak at their board meeting. He recently reached back out to them because she wanted to figure out why we were not contracted with them. They are currently contracted with the City of Binghamton and have been for the past 20 years. He was told last week it could not be done. The question he has is, years and years ago this town cut BOCES and Broome Developmental Center out of the fire protection district because of non-tax property. Now they have purchased a house next to them that is taxable property. Supervisor Marinaccio replied that once they purchased it, they extended their property, and it is now untaxed. He would like the town to revisit it. If we continue on letting the City of Binghamton come into the town and take fire properties, we are going to make the Prospect Terrace Fire Co. close its doors. They currently have a contract with Broome Developmental Center, but they almost lost that too to the City of Binghamton. They have not had the BOCES contract for 20 years. Supervisor Marinaccio explained when those 2 entities were written out of the district then they could contract with whomever they wanted to contract with. The question is if we write them back in is there still a way to get a program to still cover the fire protection for those facilities. Also, Broome Developmental Center sends out a bid package to all the surrounding fire departments around us. BOCES does not. He would like to know how that is legal. Supervisor Marinaccio explained that that has nothing to do with the Town Of Dickinson. He stressed again that they need help or it's going to force us to close our doors. Attorney Coughlin explained there is no way for the Town to force a fire contract on them. Supervisor Marinaccio explained that there is not much help we can give them because our hands are tied. If we could, he would jump on it tomorrow. The town can only do what we can do. We had legal counsel there and Attorney Coughlin claims if we changed the district grounds it may still not make a difference for the fire department. Councilperson Morabito commented that if they were put in our fire district then why would they contract with the City of Binghamton. Code Enforcer Doyle asked if the board or Supervisor could meet with BOCES and maybe ask the question that if we were to add them back to the fire district would you use our fire department. Supervisor Marinaccio agreed to do that and will contact them to have a meeting in the near future.

<u>DISCUSSION:</u> The town had a \$200,000 1- year ban for the sewer laterals for the Sunrise paving project. The closing for that bond is June 5th. The recommendation is that we pay \$50,000.00 down which is budgeted for. We also owe \$9200.00 in interest with a rate of 4.6%. We have \$30,000.00 in surplus so \$80,000 would be applied to the ban. Moving forward we would end up with a \$120,000.00 serial bond. We would lock in to a 2-year serial bond. It would be an estimated interest rate of 4.4% per year so the budget for 2025 and 2026 we would have a payment of \$60,000.00 of principal each year, which we could afford, and we would put it in the budget. The first year we would pay \$5280.00 interest then the next year we would pay \$2,640.00 interest. That would eliminate that \$200,000.00 ban.

CODE ENFORCEMENT

After speaking with Attorney Coughlin with some questions, he is going to need a site plan, along with engineering drawings, location, meets all the safety requirements that will be needed then we will need to do a building permit.
- St. Stans School some work had been done there with the front of the building as that was the biggest concern with the drainage from the roof. We will be monitoring that as part of the yearly inspections.
- New signs are being put up for the Regal Theater and Visions Credit Union.
- A code meeting is being held on May 21st @ 2:00.
