PUBLIC HEARING

1. 5:30 P.M. "A LOCAL LAW AMENDING ATTACHMENTS 4 AND 5 OF THE RESIDENTIAL ZONING REGULATIONS SCHEDULES

PUBLIC COMMENTS:

Attorney Coughlin explained that residents were building accessory structures as large if not larger than their homes which in a residential area does not work. In some rented spaces they are paving the front and back yards to add parking for tenants so this law will be proactive in protecting the town from that happening. It would also apply to a 4-family home as well. This is a standard law in most towns to protect neighborhoods and property values.

The property owner emailed him and said that the sign has been repainted and she is waiting to hear back from the contractors about fixing the potholes so happy with the progress they are making.

The planning board met with Tim on the solar project. There is a hand full of documents that need to be reviewed and submitted. Public Hearing being held May 20, 2024 at 7:00 PM.

PUBLIC COMMENTS

Supervisor Marinaccio explained that we will be discussing this further at our Regular Meeting, regarding the 1 year ban due on June 9th from the extra work that was done on Sunrise Dr. last year.

The original ban was for \$200,000. There is a balance of \$120,000. Darrell recommends that we lock into a 2-year serial bond, estimated interest is 4.4% which will leave us with a balance of \$60,000 in 2025, and \$60,000 in 2026 then it will be paid off in full. This will be discussed in further detail at our Regular meeting.

On motion by Supervisor Marinaccio, the work session was adjourned by a motion from Councilman Morabito and seconded by Councilman Burns at 5:58 PM. all in favor.
