SUPERVISOR'S MONTHLY REPORT January 2020

- 1. I reviewed the charges on our Town Credit Card accounts for June and found no issues.
- 2. Received a letter from our 2 Town Judges indicating that pursuant to Uniform Justice Court Act *2019-a, they are making the records and docket for the Dickinson Court for year 2019, available to be presented for examination. Our Court Audit will be taking place later this year and will be performed by a professional auditor.
- 3. Received a copy of the Municipal Shelter Inspection report for the Broome County Dog Shelter indicating that no issues were recorded.
- 4. Received a letter from the Broome County Health Department regarding their inspection of our Water Supply Sanitary Survey. No significant deficiencies were noted.
- 5. Once again, I would like to bring back to the board's attention that we continue to have property owners not paying their water/sewer bills. This is all residential properties. We average around \$100K per year in unpaid water/sewer bills which then goes to taxes. Most times the County makes us whole but there is always a chance that the property owner defaults on his taxes as well and if the county takes over the property, the Town is then not made whole. I think we need to take a hard

look at this with the possibility of shutting off the water supply to these properties with ample warning.

- 6. I just received word that the cost of the demolition of the Sunrise Terrace Center will be covered by the **Small Communities Grant** that the County allocated to us.
- 7. We held our press conference in regard to our \$1m water line improvement grant on Friday of last week. The media coverage was great, and I want to thank Senator Akshar once again for his assistance in receiving the grant.
- 8. Last week I briefly went over our 2019 year in our town. Thanks again to everyone who made 2019 another successful year. Goals for 2020 are simple: We need to continue to serve our constituents in the most effective and efficient manner possible. I am confident that the town council will once again do their best with their committee assignments and that includes myself. And as always, we will continue to work as a team for the betterment of our constituents.
- 9. Just a reminder to begin working on articles, notices and any other information that will be posted in the 2020 Town Newsletter.
- 10. I want to thank the **Battery Storage Project Committee** for their hard work in researching this project. I will now go over the steps that have been taken by the Battery Storage Committee to date: (see report)

- 12. I attended the last quarterly County Executive meeting held on December 18.
