# BOND RESOLUTION

BE IT RESOLVED, by the Town Board of the Town of Dickinson, Broome County, New York as follows:

RESOLUTION: AUTHORIZING THE FINANCING OF RENOVATIONS TO THE TOWN WATER LINE AT OLD STATE ROAD, OLD STATE SPUR ROAD, NORTH BROAD STREET AND NORTH LOUISA STREET, AT THE MAXIMUM ESTIMATED COST OF ONE MILLION DOLLARS (\$1,000,000.00); APPROPRIATING SAID AMOUNT FOR SUCH OURPOSE; AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$1,000,000.00 SERIAL BONDS OF SAID TOWN TO PAY THE COST THEREOF.
