SUPERVISOR'S MONTHLY REPORT October 2024

- 1. I reviewed the credit card charges and did not see any issues
- 2. We received a state aid payment in the amount of \$34,578.00 for our Town. This is the annual September AIM (Aid and Incentives to Municipalities) payment.
- 3. I received a copy of the Broome County Dog Shelter report from NYS Ag & Markets which indicated 5 unsatisfactory issues: kennels rusty, indoor trash cans in kennel area with no lids, chipped paint, rust on kennels, dog food, treats, bones, etc. must be stored properly, one dog euthanized by veterinarian without documentation.
- 4. I received the Annual Fiscal report from NYS Audit & Control.

As of August 30, 2024, our review of the 2023 Annual Financial Report (AFR) for your Town has been completed. No designation means that our town, once again, has a very good fiscal standing. Please note that No Designation is positive.

- 5. NYS Comptroller, Thomas DiNapoli, reported that sales tax revenue for August was up 3.8% which has a positive impact on our town.
- 6. I want to congratulate our Public Works Commissioner Joel Kie on his soon to take place appointment to the NY Association of Towns Resolution Committee. I am looking forward to working with Joel since my position with the Executive Board of NYAOT includes membership of the Resolutions Committee.
- Councilman Gardner and I attended the Inauguration of Tony D. Hawkins at the Forum Theater. He is the eighth president of SUNY Broome Community College.
- 8. I participated in the NY Association of Towns Supervisor's Roundtable last week and it was very interesting on how many towns in NY are exceeding the tax cap this year, some as high as 10 to 15% higher. Cost of health insurance, equipment and staff salaries were listed as the mani contributor of the increases. Thanks to the hard work of our staff and town board, we once again will remain under the 2% tax cap. As an Association, we are having discussions with our state representatives in at the very least, revise the tax cap to reflect the everincreasing costs that towns are experiencing.
- 9. As you may have heard, the NY State Supreme Court has struck down the "even year election bill" as unconstitutional. This is a tremendous win for local government across the state. An appeal is very likely.
- 10. We received the 2nd quarter fees for the inmates from other jurisdictions housed at the Broome County Jail for the amount of \$25,829.05
- 11. We will receive our AIM revenue share from the state for the amount of \$34,578.
- 12. The Annual Trunk and Treat event will once again be held at our town parking lot on October 26, starting at 1 PM.
- 13. Thanks to quit action by our finance person, Darrell, who discovered an attempt by someone to use a copy of our town check to extract a great deal of money from our account. This happened when we sent a check to a company in Texas to pay for equipment we purchased for our baseball field. We will now have additional protection on this sort of issue from our bank.

PUBLIC COMMENTS

A concerned resident commented that she would like to see a 4-way stop sign at Ukrainian Hill. The concern is there are very young children that live in the neighborhood and people do not stop at the stop sign and go by at a high rate of speed. After some discussion Supervisor Marinaccio explained that they would review it and see what we can do to make it safer.

COMMITTEE REPORTS

HIGHWAY

- Councilperson Morabito explained that they have hired 1 individual for the highway dept. His start date will be Monday Oct. 21st.
- o Brush pick up will continue till Nov. 11th and leaf pickup has begun.
- o The paving is all complete, so all the projects are completed for this year.
- Water truck body delivery will be after Thanksgiving.

WATER/SEWER

- Councilperson Exley explained that regarding the BOCES project, Water Supervisor Fitzpatrick informed her that they did not have a permit and when he confronted them about it they proceeded to tell him that they did not need one. When it comes to water/sewer projects they are definitely required to have one. Commissioner Kie explained that last Wednesday they had a round table meeting with our Code Enforcer, Water supervisor, Town Engineer and himself with their engineers, site manager, facilities manager and had a very good meeting. They are now going to communicate with our code enforcement officer. They are going to address an issue with the drainage system on Maiden Ln. while they are now improving things.
- O Town of Chenango has notified us that they are raising their water rates from \$2.65 to \$2.78. It is an annual agreement which will be \$13,000 more. They are also raising the water rates of their residents. Supervisor Marinaccio commented that we have already completed our budget so he would like to notify them and let them know we would like to know ahead of time next year and ongoing before we do our budget. The board feels this year we can absorb this increase.
- Councilperson Exley explained that Town Of Chenango has an ordinance regarding commercial backflow valves. They test the backflows prior to the date that their due which goes with the water billing. If a commercial property does not have a backflow valve the fine is levied automatically and on to their water bill. We do not have anything like that in place so the water supervisor thought that may be something to consider. Attorney Cortese explained that you can enforce any type of penalty without due process. Fees you can set and change by resolution, but you can't disguise a penalty as a fee. Regardless of how municipalities are handling it that is how they would advise it to be done. We have a couple businesses that this would pertain to. Not complying, could be fined up to \$1,000 a day.

O Councilperson Exley explained that there are about 95 to 100 accounts that are sewer only and do not pay the maintenance fee. They are hooked up to the sewer, but they have a well. They are not being charged the water/maintenance fee. The maintenance fee is covering the water. We have talked about restructuring it. People are being charged for using the sewer lines and there are other people that are not. That is not fair to the people that are being charged for it which is a valid point. The fee is mainly for water, but the board is going to review and discuss it to make sure it is fair for everyone.

DISCUSSION:

Supervisor Marinaccio commented that we have been working on our contract with Constellation and NYSEG. We have purchased our electricity from Constellation for a number of years. The contract is up for renewal in November. Supervisor Marinaccio reviewed it with Councilperson Gardner and Darrell to see if it is worth staying with them or transfer to NYSEG. Constellation said we pay on average 6.92 cents per kilowatt-hour. NYSEG rate on average would have been 5.05 cents per kilowatt-hour. This is the supplied expense. The total expense is \$84,000/year. If we had been on NYSEG we would have saved over \$7,000. Constellation has proposed a new rate for the next 12 months which would take effect on 11/1 if we choose to stay with them. The new rate would be 6.874 cents for the first year. If we stay for 24 months the rate would be 7.048 cents as they anticipate rates to go up. Councilperson Gardner recommends that we switch it all back to NYSEG for 2 reasons. We paid more last year to Constellation and also, now Darrell is paying 2 bills as we do have NYSEG power in certain areas. Councilperson Morabito commented that Constellation is a fixed rate and NYSEG was a variable so going with Constellation we have the benefit of knowing what the rate is going to be on a fixed rate but should review it each year. Supervisor Marinaccio will have to review the contract to find what type of notification we will need to cancel with Constellation. He believes it's December.

On a motion by Councilperson Gardner seconded by Councilperson Exley to approve to **DISCONTINUE OUR CONTRACT WITH CONSTELLATION AND TO SUPPLY OUR POWER NEEDS WITH NYSEG**. All in favor.

COMMENT:

Attorney Cortese gave an update on the letter that the county sent to a lot of municipalities regarding the towns being charged a fee per taxable piece of real property within the town to account for the fact that they believe under a current court decision that they are no longer able to recoup their costs of doing so through the excess cost of foreclosures that they get that are over and above the taxes that are owed. Their office had a meeting to discuss this topic, and he has taken on the task on behalf of any of their municipalities who might be interested in what recourse they have to look at contracts and statutes on whether the county can actually do this. If or what extent that they can and to the extent that there are solutions available they will be providing them to anyone that is interested and if there is some kind of uniform, template letter of opposition to the extent that towns want to oppose the implementing of these fees they will be developing that as well. He expects to have some conclusions by the end of the week. Attorney Coughlin should be distributing information on it in the very near future.

• Highway Department

- o Commissioner Kie commented that yard wastes stops Nov. 11th.
- O Commissioner Kie commented that the issue with the "Stop sign" on the Ukranian Church Rd. is an enforcement issue not a stop sign issue. The stop sign is not going to help the one street because there is hardly any traffic and the only time it will help the other street is on church day. The problem is the people drive right through the stop sign. They are going to make the law enforcement aware of the situation.

Code Enforcer Doyle explained that a individual came into the town office and requested to know who owned the property behind the building. The individual had spoken with DEC, and they told him he could not hunt off of Ridge road but that he could hunt over here. Code Enforcer Doyle told him that the town owns that part of the property. He explained that as of right now we do not have anything in code that states no hunting is allowed. Another option would be to put Post-It signs if that would help incur people as well. Attorney Cortese commented that there are many reasons why he would not be able to do that. This location is hunting in public lands which is not permittable. Another reason you would be allowing people to use public land for free

for their own benefit and that could conceivably violate the gift and loan clause constitution because you're taking animals off of public property for their own personable benefit. The board does not agree with anyone being able to hunt on the property.

O Code Enforcer Doyle gave an update on the Solar site. There was no screening as part of the review, so we are working currently with the developer to have something put in place. They are reviewing it as part of their plans. He has asked them for an update, and they are currently still reviewing and will let him know. He has gotten positive feedback from the site supervisor and said it shouldn't be a problem. Commissioner Kie commented that a plan will make it better but it's not going to solve the problem. There is no night work going on as they are completed at 5 or 6 each day. It should be completed at the end of November or the first part of December. He will keep the board informed as he is made aware of any information.
