SUPERVISOR'S MONTHLY REPORT September 2024 Town Board Meeting

- 1. I reviewed the credit card charges and did not see any issues
- 2. I plan on attending the Broome County Executive's budget address scheduled for September 12 at the Enjoi Golf Course
- 3. There were several complaints of people speeding down Terrace Dr. and other Sunrise Terrace Streets. I asked the sheriff's department to monitor and setup radar tracking in the hope that we can stop this reckless behavior. Many of those driving at excessive speeds are Terrace residents. Glenwood Rd., which is a county road, is another road where we experience excessive speeding.
- 4. On August 20th, I participated in the AOT Supervisors round table discussion. Focus was on the rising costs that have a very negative impact on our municipalities. The state-imposed tax cap was also discussed. Health Insurance, which is predicted to increase by 17%, materials, equipment, salaries, etc. were primary causes for increases to operate a town such as ours. I suggested that we review how properties that are exempt from paying property taxes, affect our ability to generate income for our town operations and possibly go to the state to come up with tax cap formulas for the various towns that have a high percentage of tax-exempt properties. Our town is at approximately 65% tax exempt. We also are planning to reach out to our state

representatives, including our governor, to create a CHIPS like funding for our water and sewer projects. Mortgage tax income is down. Sales tax may decrease for the next quarter. We are also asking that the state mandates for training and required equipment costs for 1st responders that includes our fire departments, be funded by the state.

5. **Abbreviated message from our Town Judges:** Now that we are fully staffed and nearing the end of the summer, Judge Randall and I are finalizing the court hours of operation moving forward. Please see the attachment.

No shuttering of the service window during the day. Lunch and break times will be staggered by the clerks so that the public will be able to transact court business. As is the case now, there may be some infrequent occasions where the public does come to the Court outside of "business hours," and they will be served.

- 6. We finally received our 2nd quarter inmates from other jurisdictions at the Broome County Jail for the amount of \$25,829.05
- 7. I was invited to and plan to attend the SUNY Broome President Inauguration on Oct. 1, 11:30 AM

The resident is also concerned with the Motels housing the homeless people. Supervisor Marinaccio explained it has been an ongoing problem for years as the owners get temporary assistance from Social Services to house people that can't afford a home. A few years ago, we were having a lot of problems and met with the owners and

have looked into shutting them down, but it is a very long, expensive process. It has been quiet there for the past 6 months and the police are well aware of the whole situation.
