SUPERVISOR'S REPORT

May 2025 Town Board Meeting Supervisor's Report

- 1. Reviewed the monthly town credit card statement and did not find any issues
- 2. We received a very nice letter complementing our Assessor, Jack Cahill, in which he was a tremendous help in assisting one of our residents relating to the STAR program.
- 3. I am happy to announce that the latest inspection of the County Dog Shelter by NY Agriculture found no issues at the shelter.
- 4. NYAOT has agreed to hold their Planning and Zoning School seminar here in Binghamton, at the Holiday Inn. Staff at our NYAOT office is working with Gina Calisi with the Greater Binghamton Chamber. Date and time to be announced soon.
- 5. Our first quarter sales tax distribution is \$302,904.37.
- 6. Our first quarter fees due from the county jail for inmates from other jurisdictions are \$29,996.16.
- 7. First quarter payment to the town for the Traffic Reconciliation program is \$33,600
- 8. I will be attending a meeting at the NYSEG headquarters on May 16 to get updates on various reliability projects that they are working on, electric upgrades, vegetation work and other projects.
- 9. I want to thank Councilwoman Exley for once again attending the City of Binghamton Planning Commission regarding the planned gas station project on Glenwood in the city.

- 10. As I mentioned this event last week, Broome County, in partnership with the U.S. Department of Defense and the U.S. Military's Reserve Forces, is proud to announce Healthy Broome, a community health initiative through the Innovative Readiness Training (IRT) program. Healthy Broome will offer medical, dental, optometry, and veterinary services at no cost to residents from August 11 to August 20, 2025, at the SUNY Broome Ice Center. Our veterans will have this incredible opportunity to receive much-needed services as well as the public. This is also an opportunity for the military to receive mission-ready training.
- 11. I had a discussion with Anthony, Broome County Planning Commissioner regarding the Marchuska project. Mr. Fiala said he has scheduled a meeting with Mr. Marchuska and will report back to me.
- 12. Regarding the property tax calculations that I did, I believe that the estimates are correct. The present town property taxes on the vacant property are \$362, county 625.14, school \$2496.
